**STALLION SERVICE CONTRACT – SHIPPED SEMEN**

This contract is between Rope-Race-Ride and the undersigned Owner (Mare Owner) of the mare described below.

1. **Engagement.** The Mare Owner hereby engages one breeding service to \_\_\_\_\_ (Stallion)  
 for the mare \_\_\_\_\_ Registration No. \_\_\_\_\_  
 for the 20\_\_\_\_ breeding season (March 1 – June 30).

2. **Mare’s Registration Papers.** A copy of the mare’s registration papers must be returned with this contract.

3. **Breeding Fee.** The breeding fee is \$\_\_\_\_\_, which includes a nonrefundable chute fee of \$250.00, payable in full before first shipment of semen is made. If the mare is flushed for embryos and produces more than one pregnancy in recipient mares, the Mare Owner will be charged a fee equal to 80% of the contractual breeding fee for each additional pregnancy.

4. **Shipping & Handling Fees.** Shipping and handling fees are the responsibility of the Mare Owner. Semen will be collected in the morning and shipped FedEx Priority Overnight utilizing an Equitainer or a new Equine Express II disposable shipping container. Shipping and handling fees must be paid prior to each shipment of semen. Shipping is for the continental US only. Please call for shipping outside the US. In all cases, Rope-Race-Ride makes no guarantee on the on-time arrival of shipments. Please specify shipping method preferred below.

- Equine Express II disposable container.** Mare owner will pay \$225 for each shipment of semen.
- Equitainer.** Mare owner will pay \$275 for each shipment of semen and understands that the Equitainer and all its parts are the property of Rope-Race-Ride. The Mare Owner will return the Equitainer and all its parts within 5 business days after receipt. Should the Mare Owner fail to return the Equitainer and all its parts within 5 business days a late fee of \$50 per day will be charged to the Mare Owner up to the amount of \$350 to cover the cost of the Equitainer. **The cost of returning the Equitainer is the responsibility of the Mare Owner.**

5. **Payment of Fees.** Fees may be paid by check made payable to AES, Venmo @Rope-Race-Ride, or by credit card. Checks returned for insufficient funds will incur a \$25 charge per occurrence and will void all obligations of Rope-Race-Ride under this contract. Credit card charges will have a convenience fee of 3.5% added. Please check payment method below.

6. **Orders and Cancellations.** Semen must be requested by 5pm MST the day prior to collection by calling Mike Randall at 435-691-1118. Cancellations must be made by 8am MST the day of collection. Cancellations after 8am the day of collection may be subject to a \$75 cancellation fee.

7. **Semen Handling.** Rope-Race-Ride only assumes responsibility to ship semen in viable condition and shall not be held liable for contamination of semen during and after shipment, loss of viability, or any costs arising from shipments delayed, damaged or lost in transit. The responsibility for conception is on the Mare Owner. Therefore, a qualified, experienced licensed veterinarian competent in the use and handling of cooled semen should perform the insemination on the same day that the delivery is made to the Mare Owner. Rope-Race-Ride may refuse to ship semen if they believe the insemination is not proper or the mare is not healthy. Rope-Race-Ride reserves the right to request a negative uterine culture and a uterine biopsy performed prior to shipment of semen. The Mare Owner agrees to comply with all requirements concerning the use and handling of cooled semen.

**8. Cooled Semen Disclaimer.** Semen is shipped on a first call, first serve basis with on farm mares receiving first priority. Please remember that a cooled semen contract does not guarantee semen will be available. Rope-Race-Ride makes no representation of warranties, expressed or implied, regarding the cooled semen delivered under this agreement, including and without limitation, representations or warranties that the cooled semen will safely reach the insemination point without losing its integrity, quality, or other characteristics. Rope-Race-Ride also shall not be responsible for delayed, lost or mishandled deliveries.

**9. Live Foal Guarantee.** Rope-Race-Ride provides a limited guarantee that a single live foal will result from the breeding privileges granted herein. The term "live foal" means that the foal stands and nurses without assistance. If a live foal does not result from the breeding, Mare Owner shall be entitled to return the mare or a substitute mare approved by Rope-Race-Ride, for breeding to the Stallion for the following breeding season only. If the Stallion dies, is sold, or becomes unfit for service the Mare Owner may select a substitute from Rope-Race-Ride stallions at an adjusted fee.

**10. Breeder's Certificate.** Upon notification of birth of a live foal and full payment of all fees and expenses, Rope-Race-Ride shall issue the breeder's certificate to the Mare Owner.

**11. Waiver of Liability.** Rope-Race-Ride, its owners, management, agents, veterinarians, representatives, and interns shall not be held liable for any damages arising out of or from the keeping or breeding of the mare or that may occur from any cause whatsoever in connection therewith including but not limited to accidents, sickness, escape, and/or death, whether the mare is on Rope-Race-Ride property or not. Furthermore, Mare Owner agrees that the above named parties shall not be held liable for assumed negligence or errors.

Mare Owner shall pay all reasonable attorneys' fees, paralegal fees, accountant fees and any other cost and expenses incurred by Rope-Race-Ride in pursuing collection of the sums owed under this contract.

**Please remember that a signed Stallion Service Contract (2 pages), mare's registration papers, breeding fee, and shipping and handling fees must be submitted and paid to Rope-Race-Ride prior to making a request for any shipment of semen.**
