STALLION SERVICE CONTRACT – SHIPPED SEMEN

This contract is between Rope-Race-Ride and the undersigned Owner (Mare Owner) of the mare described below.

1. **Engagement.** The Mare Owner hereby engages one breeding service to _____ (Stallion) for the mare _____ Registration No. _____ for the 20____ breeding season, which shall begin March 1st and end June 30th.

2. **Registration Papers.** A photocopy of both sides of the mare's registration papers must be returned with this contract.

3. **Breeding Fee.** The breeding fee shall be \$_____ payable in full before any shipment of semen is made.

4. **Cooled Semen Expenses.** In addition to the above stated breeding fee, Mare Owner shall pay \$300 for each shipment of semen. This covers all costs associated with the semen shipping process, including lab, handling costs, and overnight ground shipping. If shipment is counter-to-counter, there will be an additional expense of \$100 per shipment. If semen is shipped to Canada, Mare Owner will be responsible for additional costs, including, but not limited to: taxes, duties, fee, and permits. Semen picked up at the farm by Mare Owner or courier will be charged \$75 per shipment. Mare Owner agrees to pay these charges in full before any shipment of semen is made.

5. **Orders and Cancellations.** Mare Owner shall give advance notice of general shipping date. Once shipping date has been established, Mare Owner must confirm order of semen to 435-691-1119 before 5PM MST day prior to shipment. Cancellations must be made by 8AM MST the day of the shipment. Cancellations after this may be subject to a cancellation fee.

6. **Semen Handling.** The responsibility for conception is on the Mare Owner. Therefore, a qualified, experienced licensed veterinarian competent in the use and handling of cooled semen should perform the insemination. Rope-Race-Ride may refuse to ship semen if they believe the insemination is not proper or the mare is not healthy. Rope-Race-Ride reserves the right to request a negative uterine culture and a uterine biopsy performed prior to shipment of semen. The Mare Owner agrees to comply with all requirements concerning the use and handling of cooled semen.

7. **Cooled Semen Disclaimer.** Semen is shipped on a first call, first serve basis with on farm mares receiving first priority. Please remember that a cooled semen contract does not guarantee semen will be available. Rope-Race-Ride makes no representation of warranties, expressed or implied, regarding the cooled semen delivered under this agreement, including and without limitation, representations or warranties that the cooled semen will safely reach the insemination point without losing its integrity, quality, or other characteristics. Rope-Race-Ride also shall not be responsible for delayed, lost or mishandled deliveries.

8. **Equitainer.** The Mare Owner understands that the Equitainer and all its parts and pieces are the property of Rope-Race-Ride and that the Mare Owner does not obtain rights to the Equitainer by virtue of this agreement. Should the Mare Owner fail to return the Equitainer and all its parts and pieces within 5 business days after receipt a late fee of \$50.00 per day will be charged to the Mare Owner up to the amount of \$350.00 to cover the cost of the Equitainer. The cost of returning the Equitainer is the responsibility of the Mare Owner.

9. **Live Foal Guarantee.** Rope-Race-Ride provides a limited guarantee that a single live foal will result from the breeding privileges granted herein. The term "live foal" means that the foal stands and nurses without assistance. If a live foal does not result from the breeding, Mare Owner shall be entitled to return the mare or a substitute mare approved by Rope-Race-Ride, for breeding to the Stallion for the following breeding season only. If the Stallion dies or becomes unfit for service the Mare Owner may choose a refund of any money paid on the breeding fee, or a substitute may be selected from Rope-Race-Ride stallions at an adjusted fee.

10. **Breeder's Certificate.** Upon notification of birth of a live foal and full payment of all fees and expenses, Rope-Race-Ride shall issue the breeder's certificate to the Mare Owner.

11. **Waiver of Liability.** Rope-Race-Ride, its owners, management, agents, veterinarians, representatives, and guests shall not be held liable for any damages arising out of or from the keeping or breeding of the mare or that may occur from any cause whatsoever in connection therewith including but not limited to accidents, sickness, escape, and/or death, whether the mare is on Rope-Race-Ride property or not. Furthermore, Mare Owner agrees that the above named parties shall not be held liable for assumed negligence or errors.

Mare Owner shall pay all reasonable attorneys' fees, paralegal fees, accountant fees and any other cost and expenses incurred by Rope-Race-Ride in pursuing collection of the sums owed under this contract.

Upon receipt of contract and registration paper Rope-Race-Ride will contact Mare Owner with approval. This contract is not valid unless both parties have signed.

Please remember that a signed Stallion Service Contract, breeding fee, and fees for shipping must be submitted and paid to Rope-Race-Ride **prior** to making a request for any shipment of semen.
